Subject:	Runway Maintenance Works – Spring 2020	DN 03520
Date of Issue:	2nd April 2020	

It is the responsibility of all employers to ensure that relevant DN's are brought to the attention of their staff. However, individuals remain responsible for their own actions and those who are in any doubt should consult their Supervisor or Manager.

1. Introduction

This Director's Notice (DN) has been produced to advise all operators of the requirement to carry out planned closures of the runway at Stansted to all aircraft for the periods notified below, to be able to carry out essential maintenance.

Note: All times in this document are local unless otherwise stated.









2. Information

Starting Tuesday 14th April 2020 until Friday 24th April 2020 runway works will take place to carry out routine runway maintenance.

Full Runway Closures will be in place between 10:00 and 16:00 local time weekdays for a working period of 2 weeks.

 Phase 2 - Full Closure 1000-1600 local time

Full Closure works will commence between 10:00 hrs and 16:00 hrs on Weekdays starting Tuesday 14th April 2020 and finishing Friday 24th April 2020.

During works the runway will be **CLOSED** to all aircraft movements.

Late Running Aircraft

The working period each day has been constrained and the timings selected to minimize the impact on scheduled aircraft movements. As a result, there is very limited flexibility in the closure times to ensure effective possession periods each day for the works. Every effort is to be made to arrive before the closure time.


Operators with aircraft at risk of being delayed and running beyond the closure period should contact the AODM at the earliest opportunity.

Runway Slot Applications

Airport Co-ordination Ltd (ACL) has restricted automated runway slot approvals in OCS for the above period. Any slots requested during the planned closure period should be referred to the Airside Operations Duty Manager for consideration, though are unlikely to be approved in advance of the planned closure date and might only be accepted if there is any delay to, or cancellation of, the works.
