<p>Introduction:</p> <p>Gatwick has continued our focus on protecting the welfare of our staff and passengers and implemented plans to preserve the future of the business, as airlines, Governments and the public all respond to COVID-19. The challenges we face as a result of the coronavirus pandemic have continued to escalate. An increasing number of countries are closing their borders, which has resulted in a sharp decrease in passengers flying in and out of all airports, including Gatwick. We wish to inform you that as a result of the above and following a dramatic fall in airline traffic we have taken the decision to close operations in the North Terminal at 00:01 Local time on 1st April 2020 until further notice.</p>		
<p>Programme:</p> <ul style="list-style-type: none"> From 00:01L, 1st April 2020 Gatwick Airport will run a single terminal operation using the South terminal only with operational hours of 14:00 – 22:00L daily. Between 22:00 and 14:00L Local Gatwick airport will be available for Emergency traffic and divers only. The airport will be operating on minimum resource levels at this time and will only hold a CAT 7 RFFS response. Aircraft of a higher category intending to land is at the discretion of the Aircraft commander. Divert Aircraft intending to land at Gatwick will require prior permission. Ground support requirements are the responsibility of the relevant Airline. Outside of these hours CAT10 RFFS is provided. COVID 19 government measures and restrictions will also apply <p>General notes</p> <ul style="list-style-type: none"> Passenger security will be open to align with the daily flying schedule All other security posts will be available but with minimum staffing levels Access to all tenanted and retail areas will be maintained however there maybe diversions in place. Please follow any temporary wayfinding All retail stores will be closed with the exception of: <ul style="list-style-type: none"> Airside: Boots (Upper and Lower IDL) 10:00-22:00L Landside: Boots arrivals 10:00 – 22:00, M&S arrivals 08:00 – 23:00L
