Gatwick Airport Scheduling Declaration Summer 2014

Hourly Runway Scheduling Limits

- Adjustment of runway capacity in 2100UTC hour by an additional three arrival slots and reduction of 2200 hour by two arrival slots.
- Adjustment of runway capacity in 1400UTC hour reduced by one total and arrival movement and increased by one total and arrival movement in 1500UTC hour.
- The capacity declaration for Summer 2014 is now as follows:
