

## **Scheduling constraints at London City Airport - Summer 2016**

In accordance with Article 6.1 of Council Regulation (EEC) No 793/2004 amending No 95/93 and as the competent authority by virtue of regulation 6 of The Airports Slot Allocation Regulations 1993, having cooperated with representatives of air traffic control, customs and immigration authorities and air carriers using London City Airport and representative organisations, London City Airport Limited hereby declares the scheduling limits for the airport for the Summer of 2016 season as follows:

### **Opening times**

- Monday to Friday Opening times 05:30 – 21:00 UTC (06:30 – 22:00 Local)
- Saturday Opening times 05:30 – 11:30 UTC (06:30 – 12:30 Local)
- Sunday Opening times 11:30 – 21:00 UTC (12:30 – 22:00 Local)
- For scheduling purposes the first departure slot available is 5 minutes past opening time, and the first arrival slot is available 10 minutes past opening times. Last arrival and departure slots are not to be scheduled beyond 10 minutes prior to closing time.

### **UK Bank Holiday Opening times**

- Bank Holidays in Summer 2016 as follows:

- Bank Holiday opening times are 08:00 UTC (09:00 Local). First scheduled arrival 08:05 UTC (09:05 Local), first scheduled departure 08:00 UTC (09:00 Local) all other scheduling limits remain the same.

### **Runway Capacity**

- Runway 15 minutes rolling every 5 minutes – Max 10 movements. No more than 6 arrivals or 6 departures in this rolling 15 minute period.
- Runway 60 minutes rolling every 5 minutes – Max 38 movements. No more than 19 arrivals or 19 departures in this rolling 60 minute period.
- Maximum 76 movements in any 2-hour period between:
  - 06:30-08:25UTC (07:30-09:25Local) to 08:25-10:20UTC (09:25-11:20Local)
  - 16:30-18:25UTC (17:30-19:25Local) to 18:25-20:20UTC (19:25-21:25Local)
  - no more than 70 movements in any other 2 hour period.
- No more than 3 consecutive arrivals/departures at each 5 minute interval.
- 05:30-05:45 UTC (06:30-06:45 local) limit of 2 movements.
- 05:30-05:59 UTC (06:30-06:59 local) limit of 6 movements.

**Stand Capacity** *(adjusted to match W15 stand declaration)*

- Minimum of 15 minutes between a departure and an arrival on stand.
  - West apron – Allow 10 (minutes between an arrival and a departure and 5 minutes between each arrival. This is in addition to the standard 15 minute buffer.
- Stands 21-24 accommodate aircraft types A318, Avro RJ/EMB190/Q400 and smaller
- Stands 1-3, accommodate aircraft types Avro RJ/EMB190/Q400 and smaller
- Stands 4-5 & 12 accommodate aircraft types Avro RJ/EMB170/Q400 and smaller
- Stands 6-9 accommodate aircraft types Avro RJ/EMB190/Q400 and smaller
- Stand 13 & 14 accommodates aircraft types Avro RJ/EMB170 and smaller (not Q400)
- Stand 15 accommodates aircraft type ATR42 and smaller
- Stand 10 is not available for scheduling but is used for technical aircraft (back up capacity, Avro RJ/EMB190/Q400)
- Turnarounds to be no more than 30 minutes. Turnarounds longer than 30 minutes are subject to change at short notice, have to be agreed with LCY/ACL and will have no 'grandfather rights' associated with the slots (both the arrival and departure slot) Crew needs to be available to move aircraft upon request
- For the time period 09:30 – 15:30 UTC (10:30 – 16:30 Local) one EMB190 sized stand (stand 9) will be taken out of supply to safeguard stand capacity.
